TERMS OF SALE

TFRMS:

Payment terms are net 30 days O.A.C. from date of invoice. A service charge of 1.5% per month will be applied to all invoices outstanding after 30 days.

MINIMUM ORDER:

\$100.00 Net. For Parts orders \$50 Net. A \$25.00 service charge will be applied for less than minimum order. Prepaid freight \$2,500.00. Case Pack only. UPI Mixers order is not subject to Prepaid program.

PROCESSING AND SHIPPING TIME OF PURCHASE ORDERS:

Normal shipping time upon receipt of Purchase Order (cut-off time is 12:00 pm PT) is 2-3 business days.

DAMAGE MERCHANDISE AND/OR SHORTAGES:

In the event of shortage or if damage is detected in a shipment, notify the delivering carrier at once to request an inspection and file a claim promptly. Any delay may cause you a loss. Shortage or damage in shipment does not excuse the buyer from timely payment of invoice. We cannot reimburse claims for shortages or delays caused by the carrier. Apparent packing errors must be reported to us within 5 business days of merchandise received.

CONDITIONS OF RETURN:

Merchandise to be returned must have an approved Return Authorization.

- 1. Restocking charge will be 25% of returned merchandise invoice amount with a \$25.00 minimum charge.
- 2. Restocking charge of 50% will be applied for returns of used equipment and are subject to inspection.
- 3. Return shipment must be prepaid.
- 4. Returns only accepted on current merchandise found to be in original cartons and in new and saleable condition.
- 5. Authorization number must be on packing list.
- 6. Special orders or Non-stock items are not returnable.

BACK ORDERS:

Back orders will be shipped as available, transportation charges prepaid when the original order meets the minimum prepaid amount. Back orders for less than \$200.00 will be automatically cancelled.

Some variations between picture and product may occur.

WARRANTY

All products manufactured and sold by UNIWORLD are warranted to be free from defects in material or workmanship. UNIWORLD's obligation and liability is expressly limited to repairing or replacing equipment that proves to be defective in material or workmanship for one (1) year from the date of purchase, unless specified otherwise. Notice of claims under this warranty must be received in writing by UNIWORLD in timely manner in order for warranty coverage of parts to apply. Labor charges will be charged accordingly.
